The tournament Registrar will accept all applications in the order in which they were received. A team becomes an official entry after review by the Director and Registrar according to the following criteria: receipt of a completed application, receipt of a Regional check, teams providing qualified referees, posted date of tournament application. Teams selected will be notified by phone, e-mail and/or posted letter. Teams not selected will be notified by phone or posted letter within 48 hours of the entry deadline (April 3rd) and placed on a stand by list if they so choose. All entry fees will be refunded for teams not selected. Entrance and Referee fees received by a team placed on a waiting list will be cashed until final placement, and then if not placed, they will be issued a full refund. Maximum number of teams entering per Region/Division/Gender is two, unless approved by the Tournament Director. Incomplete application will be returned by mail immediately. Any team that wishes to withdraw after being accepted must contact the Registrar or Director no less than thirty (30) days prior to the tournament to receive a full refund. Within thirty (30) days of the tournament, a full refund will only be issued if a replacement team is available. A full refund will be issued if the tournament is cancelled and cannot be rescheduled. Make-up date for the tournament is May 23 & 24, 2009. All correspondence shall be addressed to the Tournament Director as listed above. Teams will be required to show proof of the player's registration/medical release forms with a "wet" signature and a copy of the roster signed by the Regional Commissioner.
